- b. Having valid Pakistan Engineering Council (PEC) license/ registration in category C-4 and above.
- c. Currently, the firm has not be blacklisted by any department/organization with documentary evidence in shape of affidavit on stamp paper.
- d. Have valid registration with KPRA and FBR and must be on active taxpayer list.

- 1. Non-compliance of above-mentioned criteria at the time of Bid opening will result in rejection of Bid irrespective of cost.
- 2. All above documents may be verified by the procuring entity, if required. In case, if a document is not verifiable, the bid will be rejected.
